#### 1. GENERAL INFORMATION

The "PULLT-M" control unit allows a shooting range to operate Compak Sporting manually, with the control unit EP095M.

This unit must be connected to J5 plug, removing the referee box if connected.

On the panel of the unit there are 8 buttons, from 1 to 8, and the Start button.

On the EP095M control unit it's possible, entering inside "Program Mode" select how many traps are used for the Compak Sporting (from 1 to 8).

#### 2. COMPOSITION

The unit "PULLT-M" consists of the following elements:

· remote control box, with 10 mt. cable

## 3. OPERATION

Select on the EP095M the discipline named: "Manual Sporting", then select shooters (from 1 to 6).

Then press START button, from the EP095M control unit or from the PULLT-M unit.

Immediately the round will start and by pressing a button from 1 to 8 of the PullT-M a correspondent target from a trap machine will be released.

The targets are immediate, as soon as a button is pressed.

By pressing START, the "Delay Condition" will be enabled. That means a target will be released after 3 sec from pressing a button from 1 to 8.

To remove the "Delay Condition", press again START button.

If a double is requested, press at same time two buttons on PULLT-M

If less than 8 traps are used, (for example only 6 traps are used), by pressing the buttons of trap not used (for example 7 or 8), no target will be release and also the EP095M will not count targets.

## 4. GUARANTEE AND ASSISTANCE
